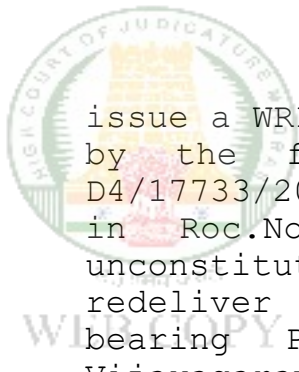

issue a WRIT OF CERTIORIFIED MANDAMUS calling for the records issued by the first respondent dt.26.10.2020 vide proceedings Kdis D4/17733/2020 and pursuant order of the 2nd respondent dt.28.12.2020 in Roc.No.A5/3186/2020 and quash the same as illegal and unconstitutional and consequently direct the respondents 3 and 4 to redeliver the secured properties measuring an extent of 4050 Sq.ft bearing Plot No.62, comprised in R.S.No.196/1,2,3,4 and 5 Vijayagarav Mudaliyar Chatram Village, Palayamkottai, Thirunelveli District, together with residential House building at Dr.No.1000, Saragam IOB Colony, Palayamkottai Ward, Thirunelveli District to the petitioner and pass such other orders as this Honble Court.
