3.Therefore, the prayer sought for in this petition has become infructuous. Accordingly, this Criminal Original Petition is dismissed as infructuous. However, the learned counsel for the petitioner submitted that while admitting this petition, already interim stay was granted by this Court. Hence, the petitioner is at liberty to challenge the final report, in the manner known to law, if so advised. Further, the learned Judicial Magistrate is directed



to take cognizance of the final report in Crime No.228 of 2021, within two weeks, from the date of receipt of a copy of this order, if not taken.
