PRAYER :-

For Anticipatory Bail in Crime No. 166 of 2019 on the file of the respondent Police.

ORDER : The Court made the following order :-

Heard the learned counsel appearing for the petitioner and the learned Government Advocate(Crl. Side) appearing for the respondent.

2.The petitioner apprehending arrest at the hands of the respondent police for the offences punishable under Sections 147, 148, 324, 302 and 201 of I.P.C., in Crime No.166 of 2019 on the file of the respondent police, seeks anticipatory bail.

3.The petitioner had earlier moved this Court by filing Crl.O.P.(MD)No.10613 of 2020. The said criminal original petition was dismissed on 30.09.2020 and I had specifically observed that the petitioner has to necessarily surrender and take regular bail.



Therefore, subsequent developments including filing of charge sheet will not make any difference. This criminal original petition stands dismissed.
