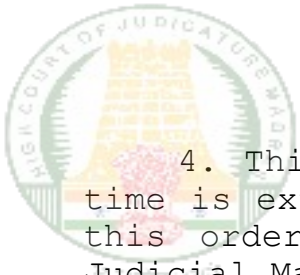

This petition has been filed to modify the conditions imposed on the petitioner by an order dated 29.12.2021 in Crl.O.P.(MD) No.21127 of 2021 (i) to appear before the concerned Magistrate within a period of fifteen days from the date on which the order copy made ready and (ii) to appear before the respondent Police daily at 10.30 am for a period of one month.

2. The learned Government Advocate would submit that till date, the petitioner has not appeared before the concerned Judicial Magistrate.
