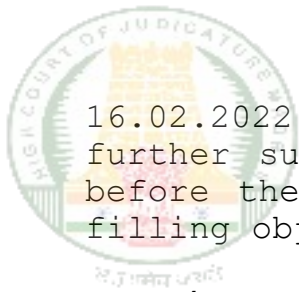
ORDER

This petition has been filed to punish the first respondent herein for their willful disobedience of the orders passed by this Court in CrI.O.P(MD) No.15023 of 2021, dated 05.10.2021.

2. By the order of this Court, dated 05.10.2021, direction was issued to the second respondent to complete the investigation and file final report before the concerned Court and also directed the learned Magistrate to process the final report as per Rules, after processing the same compliance report must be submitted to the Registry.

3. The learned Additional Public Prosecutor would submit that the investigation was completed and final report was filed on

5. Since the final report has been filed before the concerned Court, nothing survives for further consideration in this petition.

6. Accordingly, this Contempt Petition is closed and the contemnor/respondent is discharged.
