Hence, he seeks to withdraw the present writ petition, so that, the new tenant, namely, Vadivel could file a fresh writ petition, seeking electricity service connection. Since the new tenant is in possession of the property, no orders could be passed in favour of the writ petitioner. In case, if the new tenant approaches this Court, the same could be considered on merits. The writ petition stands closed. There shall be no order as to costs. Consequently, connected Miscellaneous Petition stands closed.
