respondent in Na.Ka.No.37718/F2/2011 dated 12.04.2012 and the consequential order of the fourth respondent in Na.Ka.No.Nil/A2/2013 dated 19.04.2013 and quash the same and consequently direct the respondents 3 and 4 herein to give prior permission to fill up the Secondary Grade Teacher post vacancy caused due to voluntary retirement of Tmt. P.Nesamany by giving exemption to the candidate to be appointed in the petitioner school, to pass Teacher Eligibility Test within 5 years from the date of appointment and approve the appointment.

### **ORDER**

The present writ petition has been filed by an aided school challenging an order passed by the fourth respondent herein, under which the permission sought for by the school for appointing a Secondary Grade Teacher with an exemption of Teacher Eligibility Test.
