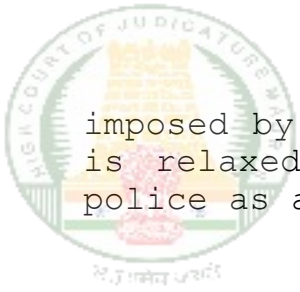
This petition has been filed to relax the condition imposed on the petitioner in Crl.O.P.(MD)No.19978 of 2021 on 15.12.2021.
