Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue a writ of certiorarified mandamus or any other appropriate writ or order or direction in the nature of writ to call for records relating to the impugned order dated 14.07.2020 in Na.Ka.No.7045/Aa2/2019 passed by the third respondent and quash the same and consequentially to direct the respondents 2 and 3 to give permission to the petitioner to fill up the post of Junior Assistant in the Hindu Nadar High School, Pudur, Vilathikulam Taluk, Thoothukudi District within a time frame that may be stipulated by this Honble Court
