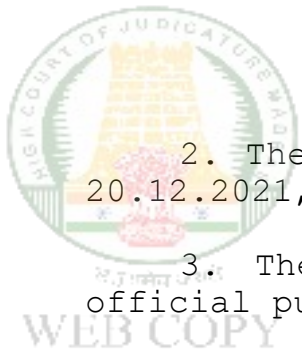
Prayer in CMP(MD). 1061/ 2021 in AS(MD). 34/2021:
