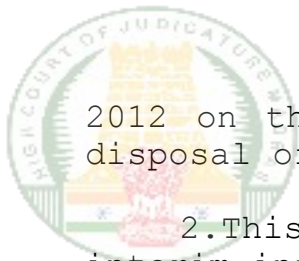

ORDER : This petition coming up for orders on this day, upon perusing the petition and the affidavit filed in support thereof and upon hearing the arguments of M/S.D.SENTHIL, Advocate for the petitioner and of MR.V.MEENAKSHI SUNDARAM, Advocate on behalf of the Respondents the court made the following order:-
