2. Heard Mr.Chamundi Bose, learned counsel for the petitioner, Mr.G.V.Vairam Santhosh, learned Additional Government Pleader appearing for respondents 1 to 3 and Mr.B.Vinoth Kumar, learned counsel for the fourth respondent.

Pointing out that the public pathway in Survey No.159 4A-15, at Keelatheru, Thumalam Village Post, Musiri Taluk, Trichy District, is encroached by the fourth respondent by constructing a wall, the petitioner submitted a representation dated 15.12.2020, to the second respondent and the same, according to learned counsel for the petitioner, is unattended.
