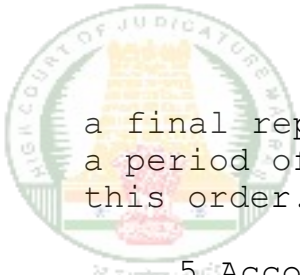
### ORDER

2.The grievance of the petitioner is that the respondent police registered a case in Crime No.480 of 2021 for the offences punishable under Sections 279, 304(A) of IPC. Till then, final report has not been filed. Hence, the petitioner filed this petition seeking transfer of investigation.

3.The learned Additional Public Prosecutor appearing for the official respondents would submit that the respondent police almost completed the investigation and final report yet to be filed.

4. In the facts and circumstances of the case, this Court does not want to interfere with the investigation at this stage. The respondent police is directed to complete the investigation and file



a final report before the concerned Jurisdictional Magistrate within a period of twelve (12) weeks from the date of receipt of a copy of this order.
