2. The grievance of the petitioner is that though he made a representation to the respondents 1 to 3 as early as on 05.01.2021 seeking removal of the encroachment made by the respondents 4 to 7 in the aforesaid survey number, till date the same has not been considered.

3. The learned Additional Government Advocate appearing for the respondents 1 to 3, on instructions, submitted that the petitioner's representation dated 05.01.2021 would be considered and appropriate action would be taken in accordance with law.

4. In view of the above, without going into the merits of the claim made by the petitioner, the respondents 1 to 3 are directed to consider the petitioner's representation dated 05.01.2021 and pass appropriate orders, if not already disposed of, on merits and in accordance with law. If there is any encroachment as pointed out by the petitioner, the same shall be removed, after giving due notice and sufficient opportunity to all the parties concerned and by following due process of law, within a period of eight (8) weeks from the date of receipt of a copy of this order.
