2.The petitioner is shown as an accused for the offence in Crime No.650 of 2020 for the offences under Section 75 of the Tamil Nadu City Police Act 1888. The case was registered on 13.06.2020. The final report should have been filed within a period of one year,



but it has not been done. Since there is no explanation forthcoming, invoking the power under Section 468 of Criminal Procedure Code, the impugned FIR is quashed.

3. With the said observation, this Criminal Original Petition is allowed. Consequently, the connected Miscellaneous Petitions are also closed.
