3.Heard Mr.R.Russel Raj, learned Counsel appearing for the petitioner, Mr.B.Thanga Aravind, learned Government Advocate (Crl.Side) appearing for the first respondent and Mr.B.Brijesh Kishore, learned Counsel appearing for the second respondent.

4.Therefore, the entire proceedings in C.C.No.216 of 2019 are quashed. Accordingly, the criminal original petition is allowed. Consequently, the connected miscellaneous petitions are also closed.
