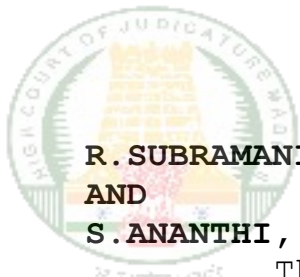

Prayer in WP(MD). 11167 of 2021 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Mandamus to direct the respondents 1 to 3 to remove the encroachments made by the 4th respondent in the public street, situated at Tholur Village, Vilathur Post, Paramakudi Taluk, Ramanathapuram District by considering the Petitioner's representation dated 16.03.2021 within the time stipulated by this Court pass such other orders as this Honble Court.

The grievance of the petitioner is that the direction issued by the Division Bench its order dated 06.07.2021 has not been complied with. The said order directs the respondent to consider the representation of the petitioner and remove the encroachment, if any after issuing notice to the 4th respondent.

2. The learned Special Government Pleader appearing for the respondents has produced the proceedings of the Tahsildar, Paramakudi, in Na.Ka.No.91/3/6440/2021, dated 09.12.2021, which shows that upon enquiry, it has been found that there was no encroachment in the public road and the alleged encroachment by Raju is not correct. It is also stated that the construction put up by the said Raju is within his patta land.

3. Hence, we find that the order has been complied with and the Contempt Petition is closed.
