Prayer in WP(MD). 15444 OF 2021 :

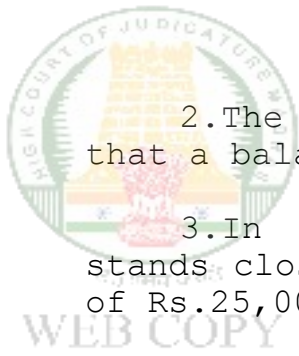
