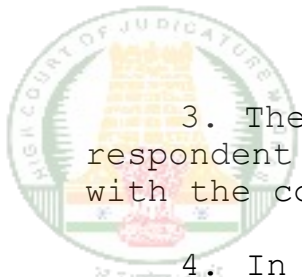
**PRAYER IN CRL A(MD)No. 378 OF 2021:**

This petition has been filed to relax the condition imposed on the petitioner in Crl.M.P(MD)No.11362 of 2021 in Crl.A(MD)No.378 of 2021, dated 03.01.2022.
