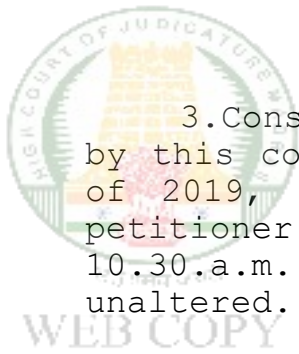
Prayer in CRL A(MD). 385/ 2019 :
