The petitioner through his counsel gives an undertaking that the organizers of the event will adhere to the police directives. The third respondent while issuing the proceedings permitting the holding of the event shall stipulate



appropriate conditions for adhering to Covid-19 protocol. I make it clear that the order has been passed in this writ petition based on the position obtaining today. It is of-course open to the third respondent to take a call, if any further lockdown restriction is imposed by the Government.
