After recording the statements made by the respective counsels, the Writ Petition is disposed of by directing the fourth respondent to permit the petitioner to write the odd semester examination scheduled to take place in February 2022 subject to payment of Rs.1000/- towards the condonation fee. There shall be no order as to costs. Consequently, connected miscellaneous petitions are closed.
