Writ Petition is filed under Article 226 of the Constitution of India, praying this Court To issue a Writ of Certiorarified Mandamus calling for the records pertaining to the impugned order of the 1st respondent made in Na.Ka.No.150109/93/Adhi7 dated 08.03.2019, quash the same with further direction directing all the respondents to change the classification of the petitioners Punja land admeasuring 2 Acres and 50 cents, comprised in Survey No.58/3C and 58/3C2 situate at Aandar Kottaram, Madurai from Adhi Dravidar Natham and restore the original classification prior to acquisition
