3.Considering the submission made on either side, time granted by this Court vide order dated 29.12.2021, made in Crl.O.P(MD) No.21001 of 2021, is extended further for a period of one week **(*) from the date of receipt of a copy of this order**, on condition that the petitioner should pay a sum of Rs.2500/- in favour of the High Court Legal Services Authority, Madurai Bench of Madras High Court, Madurai, failing which the petition stands dismissed automatically without any further reference to this Court.

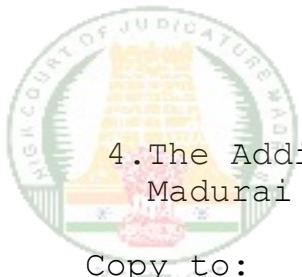
