This writ petition has been filed for a Mandamus seeking for a direction to the first and second respondents to Survey and mark the boundaries for the property comprised in Natham S.Nos.1367, 1368 in Town Survey Field Register, measuring an extent of 0163 Square Meter, situated at Manakavalan Street, Tenkasi District, by considering the petitioner's representation, dated 05.03.2021 within a time frame to be fixed by this Court.

2.The petitioner has given the aforementioned representation to the first and second respondents seeking for survey and mark the



boundaries for the aforementioned property. Since the said representation has not been considered till date, the petitioner has approached this Court.
