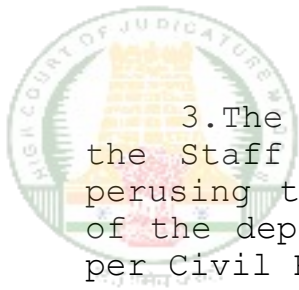
PRAYER IN AS(MD)No. 269 of 2008:
