Prayer in CRL MP(MD) . No.2317 of 2022 :-

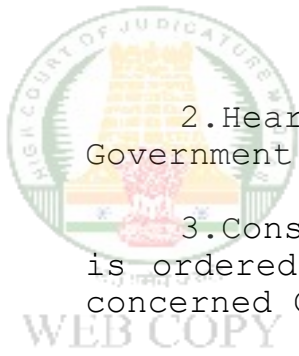
