This petition has been filed to modify the condition as 'to appear before the Inspector of Police, Melur Station, Madurai' instead of 'to report before the Inspector of Police, District Crime Branch, Sivagangai District, daily at 10.30 a.m until further order in Cr1.OP(MD)No.8569 of 2021, dated 05.01.2022.

2.The learned counsel for the petitioner would submit by the order dated 05.01.2022, he has been released on bail with some conditions. One of the condition is that he should appear before the respondent police daily at 10.30 a.m. From 03.02.2022 onwards, he is



appearing before the respondent police without fail. He is working as driver. Since, his wife is in advance stage of pregnancy and he has to travel up and down 80 km to report before the respondent police, he seeks above said modification.

3. Considering the submission made by the learned counsel for the petitioner, the condition imposed by this Court, dated 05.01.2022, is modified to the effect that the petitioner shall report before the respondent police once in a month at 10.30 a.m until further orders. The other conditions shall remain unaltered.
