4.The contemnor/respondent is present in person before this Court and submitted that the matter has been kept pending for further investigation and he seeks extension of time for completing



the investigation.

5.The contenmnor/respondent is directed to file a petition for extension of time.

6.With the above direction, this Contempt Petition is disposed of.
