This Writ Petition is filed seeking issuance of Writ of Mandamus, to direct the respondents 1 and 2 to remove the encroachment made by the respondents 3 and 4, obstructing the water channel running through S.Nos.126/1A, 126/1B1, 126/3 & 126/2 within a time frame.

2.Today, when the matter was taken up for hearing, the learned Special Government Pleader for the respondents 1 and 2 has produced the written communication of the 2nd respondent dated 08.03.2022 vide proceedings in Na.Ka.B2/1515/2022, addressed to him and submitted that there are no
