PRAYER IN CRP(MD) SR.No.20533 of 2016 :

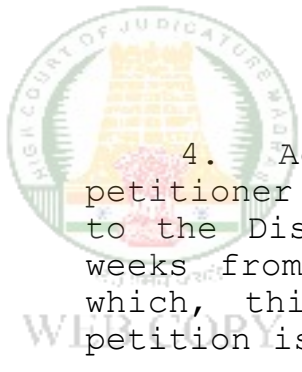
