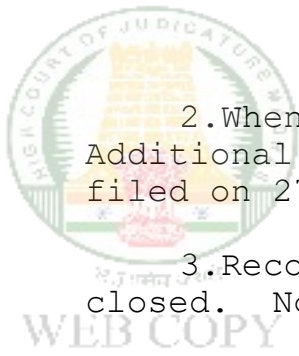
Prayer in CRL OP(MD) . 16597 OF 2019 :
