This petition has been filed to relax the condition imposed on the petitioner to appear before the trial Court on the first working day of every month at 10.30 am until further orders passed in Crl.M.P(MD).No.8945 of 2021 in Crl.A(MD).No.449 of 2021, dated 28.10.2021.

2. The petitioner counsel would submit that the petitioner is residing at New Delhi and hence, she is not in a position to appear before the trial Court as ordered by this Court.



3. The learned ASIG appearing for the respondent Police would submit that they are having office at New Delhi and hence the direction may be issued to appear before the office of the respondent.

4. Considering the facts and circumstances, the condition already imposed on the petitioner is modified to the effect that the petitioner shall appear before the respondent office situated at New Delhi on the first working day of alternative months until further orders.
