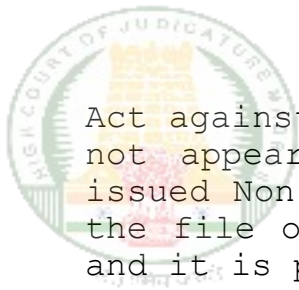

2.The petitioner is the complainant in STC No.302 of 2016 for the alleged offence under Section 138 of the Negotiable Instrument



Act against the fourth respondent herein. The fourth respondent did not appear before the trial Court, as such the trial Court has issued Non Bailable Warrant against him and the same is pending on the file of the second respondent. Till today, it was not executed and it is pending.
