ORDER

4.No prejudice will be caused to the respondents, if the petitioner's statutory appeal pending on the file of the first respondent is disposed of, within a time frame to be fixed by this Court.

5.Accordingly, this Court directs the second respondent to pass final orders on the petitioner's statutory appeal dated 22.05.2021, on merits and in accordance with law, after affording a fair hearing to the petitioner and other legal heirs of the deceased Mr.Ronald David, who is the husband of the petitioner, within a period of twelve weeks from the date of receipt of a copy of this order.

6.With the aforesaid directions, this writ petition is disposed of. No costs.
