Prayer: Writ Petition filed under Article 226 of the Constitution of India praying to issue a Writ of Mandamus directing the respondents to consider the petitioner's representation dated 10.02.2022 and to give adequate police protection for conducting "Sivarthiri Festival" in "Sri Veeru Chinnammal Kannimar Sangili Karuppasaami Thirukovil", which is situated in Koduvilarpatti Village, Theni District, on 01.03.2022 at about Morning 6.00 A.M to 02.03.2022 at Evening 6.00 p.m. for two days.

O R D E R

This Writ Petition is filed to issue a Writ of Mandamus directing the respondents to consider the petitioner's representation dated 10.02.2022 and to give adequate police protection for conducting "Sivarthiri Festival" in "Sri Veeru Chinnammal Kannimar Sangili Karuppasaami Thirukovil", which is situated in Koduvilarpatti Village, Theni District, on 01.03.2022 at about Morning 6.00 A.M to 02.03.2022 at Evening 6.00 p.m. for two days.

2.Heard the learned counsel for the petitioner as well as the learned Additional Public Prosecutor appearing on behalf of the respondents.

3.Though, the petitioner has submitted complaint before the second respondent, the correct jurisdiction police is Inspector of Police, Palani Chetti Patti (P.C.Patti) Police Station, Theni District.



4. In an identical matter, a Division Bench of this Court in an order passed in **W.P. (MD) No.8975 of 2017 dated 10.05.2017 [M.Sakthi Vs. State rep. by the Inspector of Police, Odapatti Police Station, Odapatti, Theni District]**, had granted permission to the petitioner to conduct cultural programme on certain conditions. The said conditions read as follows:

'a) The event shall be conducted in an organised and peaceful manner without causing law and order problem.

b) There shall not be any obscene or vulgar scenes during the dance performance by any one of the participants or others.

c) The cultural Program shall be restricted between 8.00 a.m. and 11.00 p.m.

d) If there is any violation of the above said conditions, the respondent or the duly authorised officer is entitled to take necessary action as per law and stop such performance.

e) In case if there is any discrepancy with regard to the date on which the program is to be conducted, it would be open to the respondent police to extend protection on some other day after giving due notice to the petitioner

f) The restrictions have now been lifted and permitted to gather not more than 50 persons for the festival function.'

5. This Court is of the view that similar conditions may also be imposed in the present writ petition. Consequently, the Writ Petition Stands allowed. The **Inspector of Police, Palani Chetti Patti (P.C.Patti) Police Station, Theni District** is directed to strictly adhere to the Standard Operating Procedure adopted by the Government of Tamil Nadu and grant permission to the writ petitioner to conduct the **Sivarathiri Festival on 01.03.2022 at about 06.00AM to 02.03.2022 at Evening 06.00PM**, at **Sri Veeru Chinnammal Kannimar Sangili Karuppasaami Thirukovil** subject to the aforesaid conditions. There shall be no order as to costs.

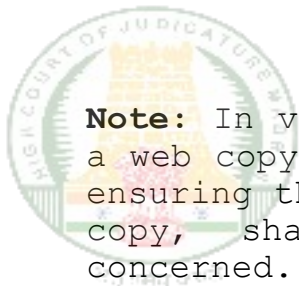
