No.2019 of 2022 and W.M.P.(MD).No.1737 of 2022 dated 02.02.2022, and then render justice.

Prayer in WP(MD). 2019/ 2022 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Certiorari to call for the records pertaining to the Impugned Order in Na.Ka.No.342/A3/2022 dated 25.01.2022 on the file of the Respondent No.4 and the consequential Impugned Order in Na.Ka.No.53/A2/2022 dated 25.01.2022 on the file of the Respondent No.5 and quash the same as illegal.

Prayer in WMP(MD). 1737/ 2022 :

To pass an order of interim stay of operation of the Impugned Order in Na.Ka.No.342/A3/2022 dated 25.01.2022 on the file of the Respondent No.4 and the consequential Impugned Order in Na.Ka.No.53/A2/2022 dated 25.01.2022 on the file of the Respondent No.5 pending disposal of the Writ Petition.
