3.Considering the reasons stated by the learned counsel for the petitioner, this petition is allowed and time is extended by two weeks from the date of receipt of copy of this order.

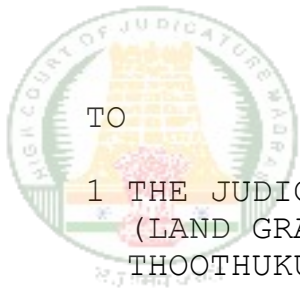
