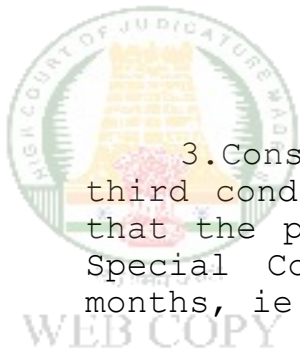
PRAYER IN CRL A(MD)No. 238 OF 2021:
