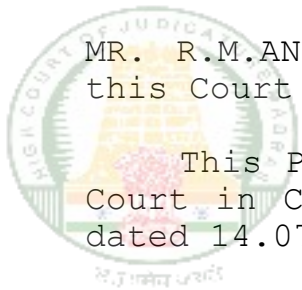
Prayer in CRL.MP.(MD) No.3132 of 2021 :-
