Subsequently, after getting clarification from the State Accountant General, the pension was fixed by considering the basic pay of Rs.59,240/- from May' 2021 and pension amount withheld to the tune of Rs.1,47,203/- was credited in the petitioner's account through RECS on 05.10.2021.

3. Recording the said submission made by the learned counsel for the third respondent, this Writ Petition is disposed of. No costs. Consequently, connected Miscellaneous Petition is closed.
