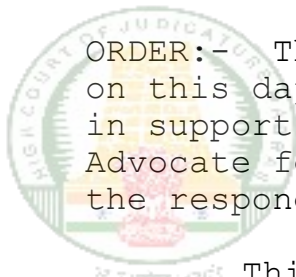

The Criminal Miscellaneous petition filed Under Section 482 of code of C.p.c. To extend by a period of 6(six) weeks, the order of modification herein relaxation passed by this Hon'ble Court in its order dt.17.2.2022 in Crl.MP.(MD).No.2509 of 2022 relaxing the condition requiring the Petitioner to attend the Court of the Sessions Judge, Special Court for Exclusive Trail of Cases uder SC/ST (PoA) Act, 1989 Sivagangai as directed under order dated 03.02.2022 in Crl.A.(MD) No.8 of 2022 on the file of this Hon'ble Court and pass such further or other orders and thus render justice.
