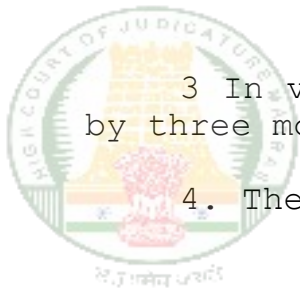
Prayer in CRL.OP(MD) .No.13118 of 2021:-
