This Criminal Original Petition has been filed seeking a direction to the second respondent to comply with the order passed by the learned Judicial Magistrate No.II, Madurai, in Cr.M.P.No.8627 of 2021 dated 17.11.2021.

2. The petitioner lodged a complaint before the second respondent and the second respondent did not conduct any enquiry. Therefore, the petitioner was constrained to file a complaint for direction under Section 156(3) Cr.P.C before Judicial Magistrate No.II, Madurai, in Crime No.8627 of 2021.
