2.The respondents 3 to 9 are the rival claimants for the very same property. The petitioner has also filed a petition before this Court in Crl.O.P(MD) No.2065 of 2021 for the same relief and the same was closed on 11.02.2021 based on the instructions given by the respondent police that the allegations are civil in nature.



3. In view of the same, the petitioner is not entitled for any police protection since the allegations are civil in nature and the petitioner ought to have approached the concerned Court for appropriate relief.

4. Hence this Criminal Original Petition stands dismissed.
