3. Considering the convenience of wife and also parties in both the cases are same, this Court is inclined to transfer both the cases to the file of the Principal District Court, Madurai to conduct joint trial

4. Accordingly, both the Transfer CMPs are allowed and the G.O.P.No.8 of 2022 and HMOP.No.268 of 2021 pending on the file of the Principal District Court, Pudukkottai and the Family Court, Pudukkottai respectively are withdrawn and transferred to the file of the Principal District Court, Madurai for joint trial. The Principal District Court, Pudukkottai and the Family Court, Pudukkottai are directed to transmit the papers to the file of the



Principal District Court, Madurai forthwith. No costs.
Consequently, the connected Miscellaneous Petitions are closed.
