2. Mr.S.Ravi, learned Additional Public Prosecutor appearing for the respondents, upon instructions, would submit that the detenue has written a registered letter to the police on 23.02.2022 claiming that she has got married to one



Thirumalainathan, S/o.Rengasamy on 10.09.2021 and her parents are threatening her and her husband's family. It is stated that the said Thirumalainathan is now working in Dubai.

3. The learned Additional Public Prosecutor would submit that the investigation by the police reveals that the facts set out in the letter are true.

4. Accordingly, there is no case of illegal detention and this Habeas Corpus Petition is, therefore, dismissed.
