COMMON ORDER

Considering the convenience of petitioner / wife, both the Transfer CMPs are allowed and both the GWOP.No.31 of 2022 and HMOP.No.22 of 2022 pending on the file of the Family Court, Thirunelveli is withdrawn and transferred to the file of the Family Court, Coimbatore, to be heard and disposed of in accordance with law. The Family Court, Thirunelveli is directed to transmit the papers to the file of the Family Court, Coimbatore forthwith. No costs. Consequently, the connected Miscellaneous Petitions are closed.
