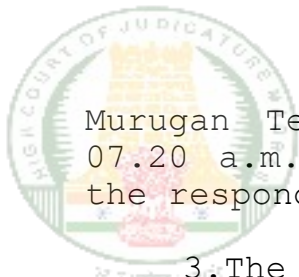

However, the learned counsel submits that a certified copy the Transfer Certificate and Community Certificate of the Bride, which are enclosed at Page Nos.17 and 25 of the Typed Set of papers, respectively, declaring that she belongs to SC Valluvan Community may be furnished to the Temple authorities.
