2.Originally, the petitioner was arrayed as accused in Crime No.70 of 2019 on the file of the respondent police. After investigation, final report has been filed by deleting the name of the petitioner. But, however, notice has been ordered to the defacto complainant by the Trial Court. Further development is not known. Now, the document is enclosed by the petitioner along with the petition.

3.Let a report be called for from the learned Judicial Magistrate-I, Padmanabhapuram, by enclosing a copy of this petition.
